



Terms and Conditions for Registration

Spejdernes Lejr 2026

Dates: 18–26 July 2026

Location: Hedeland Nature Park, Roskilde and Høje-Taastrup Municipalities

Spejdernes Lejr is a large joint project made possible by the efforts of many people. In order for the camp to be a positive experience for everyone, we rely on shared rules and expectations. These terms and conditions establish a clear framework for both participants and organisers, ensuring smooth planning and execution. By accepting them, we contribute together to making the camp a success.

1. Registration

- Registration for Spejdernes Lejr 2026 takes place via the official registration system at tilmelding.spejderneslejr.dk.
- Registration opens in October 2025 and closes in June 2026.
- All participants – scouts, leaders, volunteers, children under 6 years of age, and international guests – must be registered via the system.
- Groups will be allocated to sub-camps based on municipality. Further information about municipal allocation will be provided closer to the camp.
- New groups cannot be registered after **1 March 2026**.

2. Participant Fees

- Shared transport is included for participants aged 6 and above.
- For children aged 0–5, shared transport can be purchased separately.
- The participation fee covers activities, food, transport, infrastructure, emergency preparedness, and events.

3. Payment and Invoicing

- Invoices are issued to the registered groups as follows:
 - **1 March 2026:** First invoice (including any ordered poles/firewood)
 - **1 May 2026:** Second invoice (changes made March–April)
 - **1 July 2026:** Third invoice (changes made May–June)
 - **After the camp:** Final invoicing and transport reimbursement
- Payment by instalments is not offered.

4. Cancellation and Refunds

- Cancellations made after **1 March 2026** are subject to a cancellation fee.
- From **May 1 through June 30, 2026**, a 50% refund will be granted in the event of cancellation.
- From **1 July 2026**, no refunds will be issued in the event of cancellation.
- Changes made after July will be invoiced separately.
- Cancellation of Spejdernes Lejr due to force majeure (e.g. natural disasters or government orders) may result in a partial refund of the participation fee, minus unavoidable expenses.
- Spejdernes Lejr cannot be held liable for losses incurred due to changes, as the organiser has reserved the right to make such changes in advance.

5. Volunteers

- Volunteers must be at least 15 years old and assigned a role via the camp's job bank.
- The volunteer discount (30%) requires a minimum of 40 hours of volunteer work before, during, or after the camp.
- Cancellation after 1 March results in a cancellation fee equivalent to that of group participants.

6. Transport

- Shared transport (bus) is included for participants aged 6 and above and is available between 18–26 July 2026.
- If groups choose to arrange their own transport, a transport reimbursement will be provided based on the distance from the municipality to the camp. Spejdernes Lejr encourages groups to prioritise shared transport in order to reduce environmental impact.
- Parking for leaders and volunteers is available in designated areas with limited capacity.
- A maximum of 1 parking space per 50 groupmembers can be guaranteed.

7. Poles, Firewood, and Equipment

- Firewood (3-metre lengths) is included in the participation fee. Groups are responsible for bringing equipment to cut and transport firewood from the depot to their campsite.
- Split firewood and pioneering poles can be purchased during registration. Groups are responsible for transporting these from the depot to their campsite.
- Orders and changes for pioneering poles and firewood must be submitted no later than **1 March 2026**.
- Pioneering poles and firewood that have been ordered and paid for belong to the group and may be taken home no later than **31 July 2026**. If not collected, they will be made to wood chips and sold for the benefit of the jamboree.

8. Participants with Special Needs

- Scouts with disabilities may participate with a companion.
- The companion fee follows the volunteer camp fee (DKK 1,730).
- Expenses for the companion may be covered by the participant's home municipality.
- Participants with special needs may be accommodated in Solsikkelejren by agreement.

9. Liability and Safety

- Participation is at one's own risk.



- All groups must have a sufficient number of leaders to ensure supervision and safety. Spejdernes Lejr reserves the right to intervene if the number of leaders is deemed insufficient.
- Spejdernes Lejr has established emergency preparedness, including a camp hospital and fire services.
- Official approval is required for pole constructions over 4 metres in height or with occupancy above 2 metres. Approval must be obtained before the camp begins.

10. Insurance

- Spejdernes Lejr holds public liability insurance for the event.
- Participants and groups are responsible for arranging their own accident, travel, and equipment insurance.

11. Photography and Communication

- Photos and videos will be taken during the camp for use in Spejdernes Lejr's communication and PR.
- By registering, participants consent to the public use of images from the camp.
- Participants who do not wish to be photographed must inform their group leader.

12. Personal Data (GDPR)

- Spejdernes Lejr processes personal data in accordance with applicable data protection legislation.
- Data is used solely for the administration of registration, payment, safety, and the execution of the camp.
- Personal data will be deleted no later than 12 months after the end of the camp, unless legal requirements dictate otherwise.
- Further information on how Spejdernes Lejr processes personal data can be found in the privacy policy.

13. Changes and Reservations

- Spejdernes Lejr reserves the right to make necessary changes to the programme, prices, or terms due to unforeseen circumstances.



- The most recent and valid information will always be available at www.spejderneslejr.dk.
- If Danish authorities determine that participants from certain countries cannot attend, or if a visa application is rejected, Spejdernes Lejr reserves the right to cancel the booking and refund the jamboree fee. Any pre-paid transport costs will not be refunded.
